Marx and Greenhouse are also members of MG Advisers L.L.C. (MG), the general partner of and investment adviser to Special Situations Private Equity Fund, L.P. (SSPE). (SSF3, Cayman, and SSPE will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

This amount includes 547,703 shares of Common Stock and 208,300 Warrants owned by Cayman, 806,000 shares of Common Stock and 333,350 Warrants owned by SSPE, and 1,845,205 shares of Common Stock and 708,350 Warrants owned by SSF3.

(b) Percent of Class: Messrs. Marx and Greenhouse beneficially own 15.1% of the shares outstanding. Cayman owns 2.7% of the outstanding shares, SSPE owns 4.0% of the outstanding shares and SSF3 owns 8.8% of the outstanding shares.
