Due to his positions with RELM Wireless Corporation ("RWC"), Fundamental Global Investors, LLC and affiliated entities, Mr. Cerminara may be deemed to be a beneficial owner of the shares of Common Stock directly held by RWC, Fundamental Global Partners, LP ("FGPP"), and Fundamental Global Partners Master Fund, LP ("FGPM"). RWC, FGPP and FGPM beneficially own in the aggregate 2,400,194 shares of Common Stock, which represents approximately 7.5% of the Company's outstanding shares of Common Stock. Mr. Cerminara disclaims beneficial ownership of the shares referred to herein except to the extent of his pecuniary interest therein.
